

# CAMPGROUND RULES

## Welcome to Ceraland Park

The Ceraland campground is intended for recreational family camping. The Campground is part of 345 beautiful acres of parkland and offers a host of recreational activities. Listed are a few items that will assist in making your stay with us a pleasant experience. If you should need any additional information, please feel free to rely on our staff. We are here to assist in anyway possible.

### **Recreational Facilities & Activities**

Feel free to utilize one of our many indoor and outdoor recreational facilities. Facilities, fees and hours of operation are posted on announcement boards throughout the park. Ceraland also offers family entertainment at our Outdoor Amphitheater & Aquatic Center on select evenings and special events throughout the season. ### **Convenience Store**

Located at the Marina, our Store has some bare essentials including ice, camping supplies, fishing gear, firewood, grocery items, snacks, toiletries and first aid items. Hours of operation are posted on the announcement boards.

### **Check Out Time**

Campers must check-out before 2:00pm. Please remember to return any rented keys to the Sports & Fitness Center before leaving in order to receive your deposit.

### **General Information**

The campground is open from April 1 – October 31.

All campsites are available on a first come, first registered basis.

All camping units must register at the Sports & Fitness Center during regular park hours. Adult members are required to register for each site. ***Dependents may not camp alone.***

One (1) registered camping unit per campsite. An auxiliary tent is possible, however, it must be utilized by the same family unit. One (1) family unit per campsite. Maximum of five (5) guest camping units per family. *Please refer to the Guest Policy Rules.*

***Please back into all campsites and refrain from pulling across them. Pulling across the site can cause water and sewer lines to break from the weight of the campers.***

Each site is equipped and limited to (1) one picnic table and (1) grill or fire ring, unless approved by management.

### **Emergency**

In case of an emergency, please call 911 and notify the Front Gatehouse and Sports & Fitness Center immediately.

### **Security**

A night security watchman is provided for your convenience during June, July & August and is located at the Front Gatehouse. Please note that for additional security purposes the front gate is locked from 10:00pm – 5:00am. Key rental is available at the Sports & Fitness Center.

### **Quiet Hours**

Quiet Hours are from 10:00pm – 7:30am. Dependents are not to be left unattended in the campground after 10:00pm.

### **Telephones**

Pay phones are located at the West Bathhouse and East Bathhouse.

## **Messages**

As a courtesy, we will take messages for our guests. Please check with the Sports & Fitness Center or Park Office. No messages will be delivered to the sites unless it is in the case of an emergency.

## **Internet / Modem Access**

Located in the Sports & Fitness Center, access is available during normal hours for a fee of \$2.00 per hour.

## **Bathhouses**

There are three bathhouses located in the campground. In order to keep them clean, they will be closed daily during various times. Please note that all bathhouses are non-smoking facilities. Pets are strictly restricted from these facilities.

## **Vehicles**

Each site is limited to (2) vehicles per site. All extra vehicles must park in a designated parking lot. Please remember to display your camping permit in the windshield at all times. This permit is necessary for re-entry to the park. Campground roads must be cleared at all times. Motor vehicles may not be operated within the Park unless they are properly licensed by the State or conform with the regulations governing the operation of motor vehicles. Vehicles must be operated by persons possessing a valid driver's license. Vehicles may not be operated on walkways.

## **Guests**

All guests visiting the campground must be registered by the CERA member at the front gate prior to entry. The regular CERA Guest Policy limit of 2 vehicles with 10 guests (adults and children included) per family unit applies. Anything over the limit must be pre-approved and registered under Group Usage through the Park Office at least seven (7) days in advance.

## **Pets**

Pets are only permitted in the designated campground areas (sites 102 – 325 & pet walking area) and must be kept on a leash (maximum of six (6) foot in length) at all times. They are not allowed in the front of the park for any reason. Your pet must be attended at all times and at night, must be enclosed in your camping unit. Excessive noise will not be tolerated. **Owners are responsible for cleaning up after their pets.**

## **Severe Weather Alert**

Ceraland Park will immediately alert campers of any severe weather over the Park's PA system. The Sports & Fitness Center will be open for your shelter. Please take shelter there if you have any fear of the weather becoming violent.

## **Dumpstation**

Conveniently located next to the Rifle Range, Ceraland's dumpstation provides drive-up service for two units at one time. Please refrain from disposing of plastic gloves in the system. **Absolutely no gray water dumping on Ceraland property.**

## **Trash & Recycling**

Dumpsters are provided at various locations throughout the campground. Trash bags will be provided to you at the Sports & Fitness Center. Recycling bins are located in the front of the park. Please help keep our park clean!

## **Campfires**

Campfires are allowed in designated areas, grills, fire rings or approved fire containers. Only wood and charcoal are allowed to be burned. **No trash burning is allowed.** Only 1/2 rick of wood is allowed to be stored on a site at one time.

### ***Long Term & General Camping***

All campsites must be neat and clean at all times. No permanent clothes lines or swimming pools allowed. Long term campers (6 days or more) will be required to trim grass around campsites as needed. Campers leaving sites unattended for more than 24 hours, should turn off the water. Campers are permitted up to 14 days consecutively on lake lots. Camping unit must leave (3) days between stays on the same lake lot. Additional decks and /or platforms can only be 3' x 3' maximum in size.

### ***Things to know:***

- Ceraland locks the front gate for extra security during the summer after 10pm and you need to rent a key from the Sports & Fitness Center
- Pets are not allowed in the front of the park
- All of Ceraland's indoor facilities are non-smoking areas
- Pulling across the campsites can cause water lines and sewer lines to break
- Alcohol is not permitted in the Park or Campgrounds

### ***Special Firewood Alert:***

**Moving firewood is hazardous to Indiana's Forests due to a disease outbreak of the Emerald Ash Borer. Bringing in wood from outside of the campgrounds is limited.**
