

Check-In / Check-Out Policy

- Parking permits are issued at check-in
- All RVs' and other motor vehicles must always have permits visibly displayed
- The speed limit is 5 mph
- Check-in time is 2:00pm for cabins and campsites.
 - If available, Early check-in fee of \$10.00 must be paid
 - Early check-in is also based upon availability.
- Check-out time is at Noon for cabins and campsites
- A late check-out fee is available for \$10 which extends your stay till 7:00pm.
 - The late check-out fee is not an option if your site is reserved for the same day.
 - Late check-out is not able to be made in advance, only the evening prior to departure if available
- Any guest who has not arrived 24 hours after their check-in time and have not made prior arrangements with the Registration Office will be considered a "no show" reservation and forfeit their full reservation amount.

Guest Policy:

- RV owners or Renters are responsible for the actions of their guests/visitors.
- Guests are those listed on the reservation, visitors are those who come into the park to visit but are not staying overnight.

- Park Visitors must stop and check in with the Front Gate, Registration Office, Check-In Tent, or any other specified areas before entry into the campsite, rental unit or recreation areas.

Cancellation Policy:

- Canceling reservation 72hrs and beyond of arrival date is a 25% cancellation fee
- Canceling within 72hrs of arrival date is a 100% cancellation fee
 - To avoid fees, you may cancel and credit your guest account with CERA
 - Does not expire; Use next week, month, year
- Early departures for any reason are not eligible for refunds, only Guest Credit.
- Refunds prohibited for weather, voluntary departure, acts of nature or evictions.
- Any refund processed will be refunded in the same form it was originally paid.
- No arrival will forfeit the full deposit.
- We do not credit or refund due to discomforts of Mother Nature.

General Park Rules

- No Non-Pedal E-Bikes, E-Scooters, Hoverboards, E-Boards or such devices
- Personal alcoholic beverages are NOT permitted outside of your campsite.
 - Adult Beverages available at The Landing and special CERA events.
- Absolutely NO alcohol allowed in the Aquatic Center, Mini Golf or at youth events.
- Pets must be on a leash and attended to at all times.
- Owners are responsible for clean up and any accidents.

- Pets not allowed in the Aquatic Center, Mini Golf Course, & in cabins.
- Excessive barking or aggressive pets will need to be removed from the park.
- Service animals must be registered.
- No swimming in the Lake. Fishing is permitted during daylight hours.
- Children may not be left unattended in the campground or at facilities.
- Children must be at their site by dark unless accompanied by an adult.
- Parents are ultimately responsible for their children's behavior.
- Fireworks are strictly prohibited in the Park.
- Firearms are only permitted at the Trap/Skeet Range during posted hours.
- Air rifles, pellet guns and bow & arrows are firearms.
- Hunting is prohibited.
- All boats/kayaks must have a launch permit each day.
- Only electric trolling motors are permitted.
 - Please see the Launch Permit for full usage rules.
- Motor vehicles must observe the posted speed limits.
- Driving or parking is permitted only in designated areas.
- Motor vehicles must be properly licensed.
- Vehicles must be operated by persons possessing a valid driver's license.
- Vehicles may not be operated on walkways.
- Go-karts must register daily and operate only in designated areas.
 - Please see Go-Kart Rules for Full Track Rules and Information
- CERA Pass cards and Experience Passes are non-transferable.

- Privileges are forfeited by pass-holders and guests who permit the use of their CERA Pass or Experience Bracelets to unauthorized persons.
- No Bike / Scooter / Golf Cart riding after dark.
- Helmets are recommended.
 - This also applies to scooters
- CERA is not responsible for the loss of personal property or personal injury while attending a CERA program, or park and facilities.
- All CERA Sports Park & Campground facilities are non-smoking facilities.
- Absolutely NO smoking at Youth events.
- Vending, peddling, or distribution of any merchandise or literature is prohibited without proper vending licenses and permits.
- All waste or garbage should be placed in dumpsters and waste bins around the park.
- Fires are permitted only in grills and fire rings.
- Persons displaying objectionable behavior and/or violating the rules of the Park may be removed from the Park by CERA Management.
- Persons who have been removed from the Park will not be readmitted without the written permission of CERA Management

Campground Rules

- Must check-in at the Registration Office during regular park hours.
- You must be 18 or older to register for a campsite.
 - Under 18 may not camp alone.

- A camping unit is defined as either a travel trailer, fifth-wheel, motorcoach, pop-up, etc or any pull-behind or motorized camping coach.
- One registered camping unit + 1 Tent allowed
 - You may have 2 tents on site, ***if there is not a camping unit on site.***
- One family unit per campsite.
- Each site is equipped and limited to one picnic table and grill or fire ring, unless approved by management
- The campground is intended for recreational family camping only

Bath Houses

- There are three (3) Bath Houses located in the campground.
- Bathhouses will be closed daily during various times for cleaning.
- Please note that all bathhouses are non-smoking facilities.
- Pets are restricted from these facilities.

Camp Fires

- Allowed only at designated areas, grills, or fire rings provided by CERA
- Only wood and charcoal are allowed to be burned.
- No trash burning is allowed.
- Only 1/2 rick of wood is allowed to be stored on a site at one time.
- Do not leave fires unattended
- Do not leave fires burning overnight
- No burning trash
 - ***Any pits filled with trash or evidence of burned trash will be charged a fee depending on the amount of waste left.***

Dump Station

- Located at the North end of the campground between 4th and 5th street.
- The Dump Station provides drive-up service for two units at one time.
- No disposing of plastic gloves or any objects in the system.
- Absolutely no gray water dumping on CERA property.
- Dump Station is free of charge if camping, otherwise it is a \$15 station fee.

Children

- Children may not be left unattended in the campground or at facilities.
- Children must be at their site by dark unless accompanied by an adult.
- Absolutely no bike, scooter, hoverboard, or skateboard riding after dark.
- Parents are ultimately responsible for their children's behavior.
- Children are prohibited from going upstairs in the Sport and Center
- Children under the age of 16 must have a parent or guardian to enter facilities
 - Must not be left attended at facilities or on park grounds
 - Includes the pool, mini golf, rec center, ball diamonds, playgrounds, campground
 - Parent drop-off not permitted

Guests

- Guests visiting the campground that do not have a CERA Pass will be charged the Parking rate upon entrance to the Park.
- No guests will be allowed entry to the park after 10:00pm
- Guests are welcome to stay all day, but must leave the park by 11:00pm
- Please remember that there is a limit of 2 parked vehicles per site.

- There is parking in designated Overflow Parking Areas for additional vehicles.
 - Sites with more than two vehicles will receive a warning to move the additional vehicle
 - Further notice will result in a \$25/per additional vehicle fine

Camp Store

- Located in the Sport and Fitness Center lobby
- CERA has various fishing supplies, camping necessities, RV & tent accessories, and CERA gear for purchase.

Pets

- Pets are not permitted in cabins.
- Pets must be kept on a leash (maximum of six foot in length) at all times.
- Pets must be under owner or handler's control.
- Allowed to have a maximum of THREE PETS PER CAMPSITE.
- Pet must be attended to at all times
- Must be enclosed in your camping unit at night or when not at site.
- Excessive noise or aggressive animals will not be tolerated.
- Owners responsible for any accidents and cleaning up after their pets.
- Pet waste bags available at Dog Park or for purchase at Camp Store.

Laundry

- Laundry facility located at the bathhouse North end of 2nd and 3rd street.
- Equipped with 2 washers and 4 dryers.
- All machines are coin operated.
- Available on a first-come, first serve basis.

- Please be considerate and remove clothes immediately.
- Laundering pet items is prohibited.
- No excessively muddy clothing should be washed in these units.
- Do not wash muddy clothes in washers to preserve equipment

Internet Access

- Free wireless access is available throughout the park through **Skyweb**.
- Please note that the internet is intended for web browsing, checking emails, and other low bandwidth activities.
- Gaming, video streaming, and other high bandwidth usage is available for an additional fee through **Skyweb**.
- Please see back page of camping pamphlet for directions.
- For any internet connectivity issues please contact **Skyweb** at (989) 771-7100

Extended Stay (1 Week+)

- Campsites must be neat and clean at all times.
- No permanent structures, storage units, swimming pools, or water features allowed.
- Campers leaving sites unattended for more than 24 hours, should turn off the water.
- Tent camping is not permitted longer than 6 consecutive nights.
- Do not leave ground mats on grassy areas longer than 6 consecutive nights
 - This helps preserve the grounds for future campers

General Long-Term or Winter Camping Requirements

- RV age requirements: 10yrs old or newer to qualify for long-term or winter stays

- No Permanent Residency: Sites cannot be used as a permanent address.
 - Long-term and winter camping is for recreational use only.
- Seasonal Inspections
 - All units must pass CERA Management Seasonal and Winter Inspection before approval
- Must be able to properly winterize to ensure safe long-term and winter camping
 - CERA is not responsible for improper setups or damage that may occur.
- See CERA Staff for more seasonal camper *information and requirements*

Quiet Hours

- Quiet Hours are from 11:00pm-7:00am
- All guests must leave by 11:00pm
- You are welcome to sit around your campfire as late as you like, but please turn off all radios and hold down the noise.
- Do not disturb your neighbors!
- All children must be on site, children that are found outside of campground will be escorted by security to their site and parents will be held responsible for children's actions.

Trash

- Dumpsters are provided at various locations throughout the campground
- Trash left on site, in fire pits, or any debris will be charged to the card on file.
 - Fee will be dependent on the amount of waste.
- Please help keep our park clean!

Severe Weather Alert

- Please be aware of severe weather in the area.
- Take shelter in the Sport and Fitness Center or at the closest bathhouse if you have any fear of the weather becoming violent.
- We will have a Severe Weather Alert Announcement on a PA System.
- **Please know where your children are.**

Vehicles

- Each site is limited to two vehicles per site.
- Vehicle tags will be given at check-in.
- This tag is necessary for re-entry to the park.
- All extra vehicles must park in a designated parking lot but will not be given a car tag.
- Campground roads must be clear at all times for emergency vehicles to get through.
- All motorized vehicles (including scooters and golf carts) must be operated by persons possessing a valid driver's license.
- Vehicles may not be operated on walkways.
- No Golf Carts, bikes, mopeds, hoverboards, e-boards, e-bikes, scooter, or skateboard riding on walkways or after 10pm.
- Helmets are recommended
- Absolutely no non-pedal E-Bikes, E-Scooters, E-Boards, Standing Hoverboards, Dirt Bikes, ATVs, UTVs, Hoverboards with seat attachments, Mopeds, or such items allowed on CERA Grounds
 - This is to ensure the safety of guests, yourself, and others

- Automobiles and RV's must park on the registered site or in the designated parking spaces.
- RV's, automobiles and motorcycles must be currently registered, in good running order and operated by a licensed driver (at least 18 years of age).
 - Issues such as flat tires, dead battery, leaks, broken windows
 - RV is be deemed to be generally poor condition
 - including all exterior surfaces may not be parked in the campground.
- Golf carts can be operated only by licensed drivers at least 18 years of age and all passengers must always be safely seated.
- All guests are permitted to bring their own golf cart, provided it is in good mechanical condition, working lights, and all systems working properly and the owner may provide proof of insurance at check-in.
- No boat, utility, storage or auto trailer may be parked in the Park without prior written RV Park management approval. Vehicles in violation of these rules may be towed at the Owner's expense.
- All ATV's and Side by Sides are prohibited from the Park premises.
- We do not allow the charging of electric vehicles at your site. This includes both rental units and RV sites. Guest(s) are responsible for any damage to our property caused by attempting to charge your vehicle. Any damage done to your own property is also your responsibility. If you are caught charging your vehicle at your site you will be charged a \$100 violation fee.

Golf Carts

- Carts must be operated by someone 18 years old with a valid driver's license.
- Guests and their children who break or abuse CERA Golf Cart Rules will have cart privileges revoked or may be asked to leave the park.
- Guest must pay the permit fee to operate their cart on CERA property.
- Must have CERA Golf Cart Permit on the vehicle at all times.
- Cart must have working lights
- ATVs or UTVs are not permitted on park grounds.
- Golf carts are not permitted on Go Kart track or on Ball Diamonds.
- Those who lose Golf Cart privileges will not receive a refund.
- One person per seat on cart. No sitting on laps, standing, or riding outside the sitting area of cart.
- Alcohol is not permitted while driving your cart
- Anyone found abusing privileges or policies will forfeit these rights without refund

Park Security

- A night security watchman is provided for your convenience from Memorial Day Halloween from 10:00pm - 5:00am.
- Located at the Front Gate-House by park entrance.
- Call (812) 447-4039 for ANY SECURITY issues from 10:00pm -5:00am

Cabins

- The cabins are open from April 1 – October 31.

- All cabin renters must register at the Sports and Fitness Center during regular park hours.
- Guests must be 18+ to rent a cabin,
- No one under 18 may not camp alone.
- One (1) family unit per cabin.
- Absolutely no pets in the cabins.
- Absolutely no smoking in cabins.
 - If detected a \$250 cleaning fee will be charged.
- We do not provide bedding! Remember to pack your own linens and pillows.
- AC/Heater Unit in each cabin
- A credit card must be on file for cabin reservations.
- Tent is possible; however, it must be utilized by the same family unit.
- Each site is equipped and limited to (1) one picnic table and (1) grill or fire ring, unless approved by management.
- Bath House located across the street.
- A lost key fee, excessive cleaning fee and damage fee will be charged should any of these incidents take place during the stay.
- A CERA staff member must check and verify the cabin condition before renters may check-out and credit information is returned.
- Cabins 1 & 2 sleep 4
- Cabins 3 - 6 sleep 6

Health and Safety

- All posted signs regarding health, safety, ordinances and laws must always be observed and are strictly enforced.
- All public laws and ordinances shall be obeyed within the Park.
- The RV Owner will notify management should it become necessary.
- All emergencies dial 911.
- No hazardous material may be used or stored or dumped on the site, nor disposed of in the sewer system inside the Park at any time.
- Absolutely no loaded firearms are allowed on the park property besides for the Trap and Skeet Range.
- All weapons shall be kept in compliance with all applicable State and Federal Laws.
- The following are NOT permitted on the Park property: Unlawful weapons, fireworks, firecrackers, slingshots, bows & arrows, pellet guns, toy guns or anything that could be mistaken as a weapon.
- A working fire alarm and fire extinguisher is required in your RV.

Go-Kart Track

- Must register at Sport and Fitness Center.
- Each Driver must sign form
- Helmets are mandatory.
- Fueling and repairs of karts must be done in marked pit area.
- Go-Karts must be started only in pit area.
- Slick tires are only form of tire allowed on track.

- Go-Karts are to be driven counter clockwise.
- Any children under 18 are not allowed to drive without parental supervision and parent signature on registration form.
- No prep traction compound allowed
- All other park rules apply.

Mini Golf

- Limit playing in groups up to four (4) people.
- Ball hit off playing surface – 1 penalty stroke (replace the ball where it left the playing surface).
- Six stroke limit on all holes.
- You may move the ball six inches from any rail or fixed obstacle without penalty – no closer to the hole.
- **Be considerate of others – no profanity.**
- **Do not start on any hole until the group ahead finishes.**
- After reaching the green, player nearest the cup putts until the ball is in the cup.
- Ball hit by another ball is replaced where it was hit – no penalty.
- **Do not swing putters.**
- Stay out of all water traps and features.
- **Any horseplay on the course may result in termination of park privileges.**
- Absolutely NO ALCOHOLIC BEVERAGES OR PETS ON THE COURT

Aquatic Center

- Pool Capacity is now set at 375 Patrons

- Must be wearing experience bracelet on person to enter facility
- ***Lifeguards are not babysitters, they are here to prevent accidents***
 - Guards are expected to provide top tier water safety techniques to ensure guests a safe aquatic experience.
- No one is allowed in the pool area without a lifeguard on duty.
- **Children (Age 16 and under) CANNOT Enter without an adult**
- Children are NOT to be left unattended
- No glass, lawn furniture, radios, coolers, or outside food and drinks are allowed.
 - All food or drinks must remain in the concession area.
- Alcohol is NOT permitted at any attraction besides The Landing.
- No running, spitting, fighting, horseplay of any kind, profanity or vulgarity.
- **NO DIVING except from the diving board.**
 - **Diving at other locations in pool is strictly prohibited.**
 - **Diving in shallow waters can cause serious injury!**
- **Lifeguards reserve the right to require a swim test for any patron**
 - One length of swimming lane without stopping or touching bottom.
- Only lined swimsuits are allowed in the pool.
- **If you are a spectator and DO NOT have a swimsuit on, you MUST remain behind the fence in the concession or baby pool area.**
 - **No exceptions to this rule due to State Regulations.**
- Assisted swimming devices are the ONLY floatation devices allowed in the pool.
 - No layout, donut, or any type of lounging device in water.
- Infants REQUIRED to wear “swim diapers” while in the pool at all times.

- **Must be at least 42” to go down the slide. SEE WATER SLIDE RULES.**
- **PARENTS MAY NOT GO DOWN SLIDE WITH CHILD.**
- No glass or breakable containers, alcohol or pets are allowed in/on the pool area.
- No baby diapers are allowed in the pool.
 - Little swimmers or other appropriate swimwear must always be worn.
- No pants, shorts or cut offs.
 - Only proper swimming attire is permitted in the pool area.
- No running, jumping or diving is allowed around any of the pool area.
- Adult supervision is required for all children under the age of 16.
- Per State Law, patrons with open or infectious sores, diarrhea, or sick within the last 24hrs will not be permitted in the pool.
- **No patrons are allowed in the first aid room unless they are being treated, providing information, or are the legal guardian of a victim.**
- Rope separating the deep end must be up during all regular swimming hours.
 - NOT be used as a floatation support.
 - All patrons are restricted from leaning or hanging on the slide rope.
- Swim Breaks will be conducted everyday.
 - Children are NOT permitted in the pool during this time.
 - Children must be at least 3ft away from the edge of the pool.
- CERA Sports Park & Campground is not responsible for lost or stolen articles.

PLAY AREA

- **Must be under the age of 10 or less than 48” tall in order to enter the Play Area.**

- **An adult must be with a child who wishes to enter the Play Area.**
- Children are not to be left alone in this area
 - Lifeguards are not babysitters, please watch your children
- General Aquatic Rules still apply

Water Slide Rules

- All patrons MUST be at least 42" tall
- **Only one person at a time going down the slide.**
- All lifeguards are to measure anyone they suspect is under the required height using the measuring bar at the top of the slide.
- Guards do not dispatch the next person until the person has hit the water, recovered and exited the catch pool area.
- **Absolutely no goggles, swimmies, tubes or lifejackets on the slide.**
- NO jumping off of the slide into the pool.
- NO standing or walking on the slide.
- **Parents or other patrons are NEVER allowed to catch their children at the end of the slide.**
 - Waiting inside the water slide exit area is strictly prohibited.
 - **Waiting at the bottom of the slide can cause serious injury!**
- NO headfirst entries – ALL patrons MUST go down the slide feet first.
- All patrons going down the slide dumping into the catch pool area MUST exit the area IMMEDIATELY.
- Patrons MAY NOT swim in roped off area where the slide enters the water

Diving Well Rules

- Use nearest ladder directly to the right once exiting the diving board
- Only forward dives are allowed off the diving board.
- Must jump forward only; Not to side, or backwards.
- Absolutely NO inward dives, flip twists, or backflips of any kind.
- Only ONE BOUNCE when going off the diving board.
- Again, No back flips off the board are allowed.
- Only one person on board at a time.
- Next patron must wait their turn down on the ground, NOT on the steps.
- The previous diver MUST BE all the way to the edge of the pool before another patron will be allowed to go off the diving board.
- No Backflips.
- NO CATCHING CHILDREN IN THE DIVING WELL.
- They MUST be able to swim on their own.
- NO cartwheels, handstands, or other dangerous dives are allowed.
- Small children are NOT permitted the diving well area.
- NO swimming under the diving well rope to exit after a dive.
- NO SWIMMING ALLOWED IN THE DIVING WELL.
- This area is for the diving board & rock wall use ONLY.
- Diving of any kind at another place inside the aquatic center can result in serious injury.
- No diving besides at the Diving Well!
- ABSOLUTELY NO BACKFLIPS

Aqua Climb Rules

- **Lifeguards must be on duty.**
- **EXPERIENCED SWIMMERS ONLY.**
- Only one climber at a time on the Aqua climb.
- No guests should be in water under drop area
- All Guests need to be in a single file, starting behind the black painted line
- **NO DIVING OR FLIPS OFF WALL.**
- **FEET FIRST ENTRIES ONLY.**
- Exit the pool using the ladder on the same side of the pool.
- NO crossing in front of the diving board.
- Flotation devices or goggles are NOT permitted.
- Wait for your turn in a single file line behind the line
- No sitting along pool wall.

Indemnity

INDEMNITY. All Guests staying at Ceraland take full responsibility for any damage and/or breakages incurred during their stay. Ceraland takes no responsibility for any lost or stolen items from accommodation or vehicles and suggests that all guests securely lock their accommodation and/or motor vehicle when unoccupied. No refunds will be issued.
