

CERA SPORTS PARK & CAMPGROUND

General Information

The campground is open from April 1 – October 31.

All cabin renters must register at the Sports and Fitness Center during regular park hours. Adult members (age 18 & older) are required to register for each cabin. ***Dependents may not camp alone.***

One (1) family unit per cabin. An auxiliary tent is possible; however, it must be utilized by the same family unit.

Each site is equipped and limited to (1) one picnic table and (1) grill or fire ring, unless approved by management.

All CERA facilities are non-smoking facilities.

The campground is intended for recreational family camping only.

Alcohol and / or fireworks are not permitted in the Park or Campgrounds

Bathhouses

There are three bathhouses located in the campground. In order to keep them clean, they will be closed daily during various times. Please note that all bathhouses are non-smoking facilities. Pets are strictly restricted from these facilities.

Campfires

Campfires are allowed in designated areas, grills, fire rings or approved fire containers. Only wood and charcoal are allowed to be burned. ***No trash burning is allowed.*** Only 1/2 rick of wood is allowed to be stored on a site at one time.

Check In / Check Out

Cabin check-out is 12:00pm. Cabin check in & out must be done at the Sports & Fitness Center.

A lost key fee, excessive cleaning fee and damage fee will be charged should any of these incidents take place during the stay. A copy of the renter's driver's license and credit card will be taken at check-in and held until checkout once the cabin is confirmed to be in good order (i.e. trash bagged and disposed of, cabin cleaned, all equipment / furniture in good order, key returned to front desk at Sports & Fitness Center, fire extinguished, etc.). A CERA staff member must check and verify the cabin condition before renters may check-out and credit information is returned.

Dumpstation

Conveniently located next to the Rifle Range, Ceraland's dumpstation provides drive-up service for two units at one time. Please refrain from disposing of plastic gloves in the system. ***Absolutely no gray water dumping on Ceraland property.***

Emergency

In case of an emergency, please call 911 and notify the Sports & Fitness Center (812) 377-5849 during the day OR Security at (812)350-4456 after 10pm.

Guests

Any guests visiting the campgrounds that do not have an Annual Pass will be charged the Day Pass rate upon entrance to the Park. No guests will be allowed entry to the Park after 9:00pm. Guests are welcome to stay all day, but must leave the park by 10:00pm.

Please remember that there is a limit of 2 parked vehicles per site.

Internet / Modem Access

Wireless access is available in the Sports & Fitness Center and at various hot spots in the front portion of the park.

Laundry Facility

The laundry facility, located outside of the bathhouse across from the Rifle Range, is equipped with 2 washers and 4 dryers. All machines are coin operated and available on a first-come, first serve basis. \$1 per load to wash or dry.

Long Term & General Camping

All campsites must be neat and clean at all times. No permanent clothes lines or swimming pools allowed. Long term campers (6 days or more) will be required to trim grass around campsites as needed. Campers leaving sites unattended for more than 24 hours, should turn off the water. Additional decks and /or platforms can only be 3' x 3' maximum in size.

Messages

As a courtesy, we will take messages for our guests. Please check with the Sports & Fitness Center or Park Office. No messages will be delivered to the sites unless it is in the case of an emergency.

Pets

Pets are only permitted in the designated campground areas (sites 102-325 and pet walking area) and must be kept on a leash (maximum of six (6) foot in length) at all times and under your control. They are not allowed in the front of the park or in the cabins for any reason. Your pet must be attended at all times and at night, must be enclosed in your camping unit. Excessive noise will not be tolerated. ***Owners are responsible for cleaning up after their pets.***

Quiet Hours

Quiet Hours are from 10:00pm – 7:30am. Dependents are not to be left unattended in the campground after 10:00pm. All guests must leave by 10:00pm. You are welcome to sit around your campfire as late as you like, but please turn off all radios and hold down the noise. *Do not disturb your neighbors!*

Security

A night security watchman is provided for your convenience from Memorial Day – Labor Day from 10:00pm – 5:00am and is located at the Front Gatehouse. Please call (812) 350-4456 for ANY SECURITY issues from 10:00pm – 5:00am. For additional security purposes the front gate is secured from 10:00pm – 5:00pm.

Severe Weather Alert

Ceraland Park will immediately alert campers of any severe weather over the Park's PA system. The Sports & Fitness Center will be open for your shelter. Please take shelter there if you have any fear of the weather becoming violent.

Trash

Dumpsters are provided at various locations throughout the campground. Trash bags will be provided to you at the Sports & Fitness Center. *Please help keep our park clean!*

Vehicles

Each site is limited to two (2) vehicles per site. All extra vehicles must park in a designated parking lot. Campground roads must be clear at all times for emergency vehicles to get through. Please remember to display your camping permit tag in the windshield at all times. This tag is necessary for re-entry to the park.

All motorized vehicles (including scooters) must be operated by persons possessing a valid driver's license. Vehicles may not be operated on walkways.

Bicycle riding is not permitted on walkways. No bike riding after dark. Helmets are recommended.
